## Truth in Savings Disclosure

This disclosure contains the rules that govern your deposit account as of September 21, 2015

<b>Account Description</b>	
<b>Kasasa Cash®:</b>	A free, variable rate checking account with no minimum balance that rewards accountholders with dividends and nationwide ATM fee refunds when they meet minimum qualifications during the account's Monthly Qualification Cycles.
<b>People Driven Credit Union's Expectations</b>	
<b>Purpose &amp; Expected Use:</b>	<p>This account is intended to be the accountholder's primary checking account in which payroll transactions and <u>day-to-day</u> spending activities including but not limited to grocery, gasoline, apparel, shopping, dining, sporting and entertainment transactions are posted and settled.</p> <p>Commensurate with the spending activities identified above, we expect the account's debit card to be used frequently throughout each month and for transaction amounts to reflect a wide dollar range. Small debit card transactions conducted on the same day at a single merchant and/or multiple transactions made during a condensed time period particularly near the end of a Monthly Qualification Cycle <u>are not</u> considered normal, day-to-day spending behavior. These types of transactions appear to be conducted with the sole purpose of qualifying for the account's rewards and thus will be deemed inappropriate transactions and <u>will not</u> count toward earning the account's rewards.</p> <p>People Driven Credit Union reserves the right to determine if the account is being maintained for a purpose other than day-to-day, primary use. Accountholders who persist in making debit card transactions in a calculated and limited fashion in order to meet their monthly qualifications may have their accounts converted to a different checking account or closed altogether. We also reserve the right to convert the account to a different checking account if the account does not have consistent active use over six (6) consecutive Statement Cycles.</p> <p>We have the right to close this account at any time, with proper notice. Our decision to close the account will not affect your existing obligations to us including any obligation to pay fees or charges incurred prior to termination. No deposits will be accepted and no checks will be paid after the account is closed. If the account is closed, you will forfeit any rewards that have not been credited to your account. A People Driven Credit Union check for the remaining balance, if applicable, will be mailed to accountholder at the address indicated on our current records. Upon termination of your Kasasa Cash account, any optional add-on products / services associated with this account will also be terminated at the same time.</p>
<b>Dividend Rate &amp; Annual Percentage Yield</b>	
<b>Compounding &amp; Crediting:</b>	Dividends will accrue on a daily basis and will be credited to your account on the last day of the current Statement Cycle. If you close your account before the dividends are credited, you will not receive the accrued dividends. Dividends begin to accrue on the Business Day you deposit cash and noncash items (for example, checks). "Business Day" means any calendar day other than a Sunday in which the credit union is open to the public for the purpose of carrying out substantially all of its banking functions
<b>Balance Computation Method:</b>	We use the average daily balance method to calculate the dividends on your account. This method applies a periodic rate to the average daily balance in the account for the period. The average daily balance is calculated by adding the principal in the account for each day of the period and dividing that figure by the number of days in the period. The period we use is the statement cycle.

<b>Dividend Rate &amp; Annual Percentage Yield:</b>	When your Kasasa Cash account qualifications are met during a Monthly Qualification Cycle, Tier 1: A dividend rate of 1.98% will be paid on the portion of your average daily balance that is less than \$10,000. The annual percentage yield* for this tier is 2.00%. Tier 2: A dividend rate of 0.15% will be paid on the portion of your average daily balance that is greater than \$10,000. The annual percentage yield* for this tier will range from 0.32% to 2.00%, depending on the balance in the account. When your Kasasa Cash account qualifications are not met, the dividend rate paid on the entire balance will be 0.05% with an annual percentage yield* of 0.05%.

<b>Qualifications:</b>	<p>To earn your rewards just do the following transactions and activities in your Kasasa Cash account during each Monthly Qualification Cycle</p> <ul style="list-style-type: none"> <li>• Have at least a combined total of 12 PIN-based, signature-based debit card purchases post and settle</li> <li>• Be enrolled in and agree to receive e-Statements</li> <li>• Be enrolled in and log into online banking</li> </ul> <p>Transactions and activities may take one (1) or more Business Days from the date the transaction or activity occurred to post and settle to the account. The following activities do not count toward earning account rewards: ATM-processed transactions, transfers between accounts, debit card purchases processed by merchants and received by People Driven Credit Union as ATM transactions, non-retail payment transactions and purchases made with non-People Driven Credit Union issued debit cards "Statement Cycle" means the period of time for which People Driven Credit Union provides a summary of the financial activities and transactions that post and settle to the account holder's account. "Monthly Qualification Cycle" means a period beginning one (1) Business Day prior to the first day of the current Statement Cycle through one (1) Business Day prior to the close of the current Statement Cycle</p>

<b>Dividends:</b>	(1) A dividend rate of 1.98% will be paid on the portion of your average daily balance that is less than \$10,000. and the annual percentage yield* for this tier is 2.00%. A dividend rate of 0.15% will be paid on the portion of your average daily balance that is greater than \$10,000 resulting in annual percentage yield* for this tier ranging from 0.32% to 2.00%, depending on the account's balance and	All balances earn a dividend rate of 0.05% with an annual percentage yield* of 0.05% and
<b>ATM Fee Refunds:</b>	2) The account will receive reimbursements up to \$20. (\$4.99 per single transaction) for nationwide ATM fees incurred during the Monthly Qualification Cycle in which you qualified. Note Foreign or international transaction fees are not reimbursed If you believe you have not been reimbursed the correct amount of ATM fees you must contact us within thirty (30) calendar days after the Statement Cycle where the reimbursement was applicable in order to receive a refund.	Nationwide ATM fees are not reimbursed.

<b>APY:</b>	APY = Annual Percentage Yield*. Rates and rewards are variable and at our discretion may change after account is opened without notice to you. Fees may reduce earnings. APY calculations are based on an assumed total account balance of \$10,000. plus \$100,000. Dividends are paid from current income and available earnings, after required transfers to reserves at the end of the dividend period.
<b>Reward Distribution:</b>	Dividends and ATM fee reimbursements will be credited to the account on the last day of the current Statement Cycle.
<b>Additional Information</b>	
<b>Deposit &amp; Balances:</b>	\$25. minimum deposit is required to open the account and no minimum balance is required to obtain the account's rewards.
<b>Conditions of the Account:</b>	This account is not to be used for commercial purposes and there is a limit of one (1) account per social security number. Enrollment in electronic services (e.g. online banking and electronic statements may be required to meet some of this account's qualifications.
<b>Fees:</b>	There are no fees to open or close this account. There are no recurring monthly service charges associated with this account. See accompanying Fee Schedule for fees that may apply to this account.
<b>Questions:</b>	Contact a People Driven Credit Union service representative for additional information, details and enrollment instructions.
<b>Deposit Insurance:</b>	Federally insured by NCUA.
<b>Overdraft Protection:</b>	People Driven Credit Union offers an <u>optional</u> overdraft protection plans to protect you from overdrafts and declined transactions that you must opt into if you qualify. It is a service that enables us to pay certain transactions for you even when funds are not available in your checking account or another overdraft source. An overdraft occurs when you do not have enough money in your account to cover a transaction. The following fees are applicable: Returned Check Fee for each item we do not pay; Courtesy Pay Fee for each item we pay when no funds are available to pay an item; Overdraft Transfer Fee for transferring available funds from another share to pay an item. The fees may be imposed for covering overdrafts created by check, in-person withdrawal or point of sale (POS) debit card transactions.
